

Zurich Master Superannuation Fund Information for employers

This form provides all the information an employer will require in order to pay a contribution to the Zurich Master Superannuation Fund (the Fund), including a letter of compliance from the Trustee stating that the Fund is a complying superannuation fund and that it accepts employer contributions (overleaf).

2 Contribution options

2.1 BPAY



Using the relevant BPAY Biller Code and the member's Customer Reference Number, the employer can process contributions for each member via BPAY. The employer needs to process each member transaction individually using these details.

BPAY Procedure:

- 1. Log into internet banking or telephone banking
- 2. Select the BPAY or bill payment option and follow the instructions to enter the appropriate biller code based on the contribution type, the member's individual Customer Reference Number* and the contribution amount.
- 3. Record the receipt number.

*If member details in section 1 is not completed, please ring the Zurich Customer Care team for the member's Customer Reference Number

2.2 Direct Debit

By participating in this option the employer authorises Zurich to draw a nominated amount automatically from their Australian bank, building society or credit union account monthly, quarterly, half-yearly or yearly on the date specified on the form.

To take advantage of this option the employer will be required to complete a Direct Debit request form. For a copy of this form, please ring the Zurich Customer Care team on 131 551.

2.3 Cheque

To ensure contributions are invested correctly, please include a letter stating the type of contribution for each payment, together with 3 of the following client identifiers: Policy Number, Name, Address, Date of Birth. Please make cheques payable to Zurich Australia Limited. All cheques must be in Australian dollars and drawn on an Australian bank.

Cheques, together with the letter identifying the member (including at least 3 identifiers) should be sent to:
